

MINUTES OF THE EXTRA-ORDINARY ERLESTOKE PARISH COUNCIL MEETING

14th August 2008

Open Forum:

Cllr Jonik explained how this meeting had come about. The Parish Council had unanimously voted to remain with The Lavingtons in 2009. Wiltshire County Council made recommendations and sent them to the Boundary Committee. The Boundary Committee then changed WCC recommendations and these are what the council has to respond to by the 24th of August. Wiltshire County Council has already voted on the recommendations and has voted to accept them. Cllr Rugg and Cllr Swabey (from Ethandune) voted against the recommendation for Erlestoke but WCC voted on block to accept every recommendation put forward.

Each person present then had a chance to make their concerns known and a list was prepared of objections as follows:

1. Village business is to the east of the county not the west
2. Due to village hall closing organisations are using Great Cheverell village hall for functions
3. Medical services are in The Lavingtons as are local schools
4. Since the closure of Erlestoke village shop and Post Office, the villagers have been advised to use the shop and Post Office at Great Cheverell
5. Local identity
6. More transport services travel east then west
7. Local links on all levels are to the east and Devizes rather than to the west and Westbury

The clerk asked for a show of hands of those residents who wanted to stay with The Lavingtons which was unanimous.

The open forum was then closed and the main meeting commenced.

It was proposed by Cllr Jonik and seconded by Cllr Pinnington that the clerk writes a robust letter to Mr James Ansell at the Boundary Committee based around the list of objections compiled in the open forum as follows:

3. Medical services are in The Lavingtons as are local schools
