#### 59/09 How to call a Parish Poll

The clerk was recently asked by Mr Ryan from the village who a Parish Poll is called. Having now found the information she presented the following from the Local Government Act 1972 schedule 12 paragraph 18 sub (4) to the council:

"A Poll may be demanded before the conclusion of a parish meeting (not parish council meeting) on any question arising at the meeting; but no poll shall be taken unless either the person presiding at the meeting consents or the poll is demanded by not less then ten, or one-third, of the local government electors present at the meeting, whichever is the less."

If such a poll is agreed on then the Wiltshire Council Returning Officer would be notified and would arrange the event on the Parish's behalf but at the Parish Councils cost. Notices would be placed in the parish not less than 5 days before the poll giving times and places to vote. No postal voting is allowed and only those listed as an elector in the said parish may vote on the issue.

The clerk said she was still in consultation with the councils solicitor on the correct wording.

## 61/09 Sub Station - decide on siting of new station

Cllr Jonik explained that the council had approached each household in The Park to gain their views on the siting of the new sub station. Cllr Morgan-Frise kindly prepared and delivered the questionnaire and map and presented the following replies:

**Option1**. To site the new station adjacent to the existing sub station – 5 votes

Option 2. To site the new station next to the new Car Park – 8 votes

In view of this the following was agreed: In light of the views of the residents of the Park, the Parish Council has decided to adopt option 2 as its preferred option for the siting of the new substation. The clerk will write to the SEB advising of the councils decision.

## 62/09 Broken Bench from the play area

Further to the damage to the bench and the subsequent removal of it from the fenced play area by Cllr Jonik, it was decided that a more robust bench should be installed in the play area. The bench being built by Mr Seabourne would be more substantial and therefore the council agreed to have this bench installed in the play area. The clerk will contact G B Sport and Leisure regarding the installation of the broken bench not having been carried out in a safe manner on soft ground and that the seat was not fit for purpose. The council request a new seat to be re-installed in the open Park Area.
